

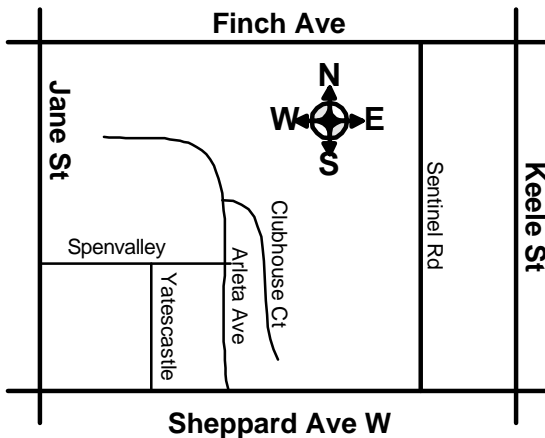


Winter Meetings Start October 3rd at the Northwood Center @ 7:30pm
